LSS Launches VITA program for current and former foster youth

LSS of Northern California is thrilled to share a new partnership to provide free tax filing services to current and former foster youth in Northern California. Working in collaboration with United Ways of California, John Burton Advocates for Youth (JBAY) and the State of California Franchise Tax Board, LSS is now a host in the

VITA (Volunteer Income Tax Assistance) program. Beginning February 1, we will have volunteers available to assist this population in preparing their federal income taxes



AND receiving the tax credits for which they qualify. We have host sites in Sacramento and Concord, but any youth can participate through a remote option.

With little background in employment or tax filing, many transition aged youth either avoid filing taxes (much to their detriment later), complete them on their own or work with flawed guidance. The result is that many of them fail to secure all the credits allowable by law, including the foster youth tax credit.

"Our mission is to guide the youth we serve to live stable, robust lives," says Kate Hutchinson, Deputy Director of Inland Programming at LSS. "This opportunity is another critical way in which we can do this."

CEO CORNER LSS partners with the community

At LSS of Northern California, we are well aware that ending homelessness...for good is a community activity. Every day our program staff in our 36+ programs are providing the case management, supportive services, guidance and friendship to those who are unhoused, newly housed or at risk of losing their housing in our region. Additionally, members of the LSS team are engaging movers and shakers throughout Northern California—elected officials, colleagues and partners—to work together in every way we can to alleviate the distress, trauma and overwhelming challenges that many in our region are experiencing.

From January 22-25, Deputy Director of Inland Programs Kate Hutchinson and I attended the Lutheran Services in America (LSA CEO Summit in Arizona, where we discussed and addressed various issues faced by many social services organizations around the country. LSA is a national network of more than 300 nonprofits "dedicated to achieving a healthier, more equitable future for people and communities in the United States." It is a partnership of service organizations like LSS of Northern California, the Evangelical Lutheran Church in America (ELCA and The Lutheran Church-Missouri Synod (LCMS. The regional ELCA Sierra-Pacific Synod and LCMS





California-Nevada-Hawaii District are our direct partners. I participated in two panels at the Summit. The first was on *Innovative Partnerships to Advance Strategy* where I talked about how LSS develops and maintains good partnerships (pictured above. The second was on *Medicaid Managed Care, Medicare Advantage and Value-based Payments: How Do They Work and Are They Financially Viable*, where I was able to share the details and successes of our growing CalAIM program in partnership with managed care providers.

Among her many other activities, Kate Hutchinson is Chair of the San Joaquin County Continuum of Care, which connects all the homeless service providers in that county. She was also integral in Sacramento's receiving a \$6.5 million Youth Homelessness Demonstration Program (YHDP) grant from the federal Department of Housing and Urban Development (HUD). More on that in a feature story coming soon. San Francisco Deputy Director JP Soto is a member of the San Francisco Interfaith Council (pictured), which,



among other things, hosts the annual Winter Shelter. He is also on local and state-wide HIV service planning committees.



In March, Program Manager Jason Sitar is speaking at the Health, Education, and Career (HEC Conference for high school youth in foster care to share with them the opportunities that LSS and other organizations have for them as they finish high school, leave the foster care system and move on in their lives. In May, representatives of our San Francisco HIV-services program team are presenting at the SF HIV/AIDS Provider Network.


Development Director Jerry Metzker regularly attends outreach events and meetings with our concerned neighbors and partners throughout the region.

He is currently planning a monthlong series of activities at Lutheran Church of the Incarnation in Davis.
