PROTECT HUD FUNDING IN CA-18: Ensuring Housing Stability for Our Communities

What is HUD? Vital Programs for CA-18 The U.S. Department of Housing and Urban Development (HUD) provides crucial support through programs like:

- Housing Choice Vouchers (Section 8): Helps low-income families afford housing.
- Continuum of Care (CoC) grants: Funds homelessness services.
- **HOME & CDBG**: Supports affordable housing and community development.

CA-18 Housing By the Numbers - Housing Choice Vouchers currently serve:

- 11,000+ households via Santa Clara County Housing Authority (district portions)
- 8,000+ households via Housing Authority of the County of Santa Cruz (Watsonville area)
- 12,000+ households via Housing Authority of the County of Monterey (Salinas area)

Community Development & Infrastructure:

- CDBG funds support infrastructure improvements in agricultural communities
- HUD investments target transit-oriented development and farmworker housing
- Neighborhood revitalization funded in underserved areas
- Flood prevention and climate resilience efforts in Salinas Valley

Affordable Housing Projects:

- Laurel Drive Project: 132-unit affordable housing complex in Salinas
- Eden Housing Development: 100+ unit farmworker housing in Monterey County
- Gateway Apartments: Senior housing in Salinas with 1-bedroom units for residents aged 55+
- Housing waiting lists receive 5× more applications than available units

The Housing Crisis in Numbers

- 31,000+ households rely on Housing Choice Vouchers in the district
- Housing costs ↑ 65% since 2020 | Wages ↑ only 18%
- 2-bedroom rent: \$2,590/month (Salinas) to \$3,040/month (San Jose)
- 34% of renters spend over 50% of income on rent

The Impossible Gap

- Average voucher recipient earns: \$21,500/year
- Living wage needed for a family of four: \$46,500/year per adult
- → Voucher recipients would need to more than double their income

Impact on District Residents - Vulnerable populations:

- Many households earn less than 30% of Area Median Income (\$55,290 for 1 person, \$78,950 for a family of 4)
- 20% of public housing units are occupied by disabled residents
- 23% of public housing units are occupied by seniors
- Large farmworker population faces unique seasonal income and housing needs

Agricultural Community Challenges:

- · Limited affordable housing in rural areas of Monterey, San Benito, and Santa Cruz Counties
- Transportation barriers exacerbate housing insecurity
- Farmworker families face displacement as housing costs rise
- Rural communities disproportionately impacted by housing shortages

Time to Take Action!

Threats to HUD Funding - Proposed Cuts Include:

- 40% reduction in rental assistance funding
- Elimination of traditional Section 8 voucher program
- Two-year time limits for "able-bodied" recipients
- · Block grants with fewer federal protections
- \$700+ million cut from homelessness programs

If Funding is Reduced:

- 31,000+ households in CA-18 could lose their housing vouchers
- Affordable housing projects like the Laurel Drive Project would be at risk
- · Homelessness would rise—especially among seniors, farmworkers, and disabled residents
- · Economic instability could increase as agricultural communities lose workforce housing
