Protect Medicaid Funding in Congressional District 17

Medicaid (**Medi-Cal** in California) provides healthcare for 15+ million Californians. Federal cuts would severely impact healthcare access statewide.

California's Medi-Cal Funding

Total funding: \$174.6 billion (FY 2024-25)

\$107.5B Federal funding (62%) \$37.6B State general fund (22%)

\$29.5B Local government, health plan fees, provider taxes (16%) (also under threat of cuts)

Direct Impact on Silicon Valley CA-17

Tech industry service workforce vulnerability: CA-17 includes Silicon Valley communities in Santa Clara and Alameda Counties where many service workers, contractors, and their families depend on Medi-Cal for healthcare access

Diverse urban and suburban communities at risk: The district spans cities like Sunnyvale, Santa Clara, Cupertino, Fremont, and parts of San Jose where working families, immigrants, and service sector employees rely heavily on Medi-Cal

Critical healthcare infrastructure threatened: Regional medical centers like Santa Clara Valley Medical Center serve as vital healthcare hubs, with Medicaid funding essential for maintaining services Healthcare equity challenges: Despite being home to some of the world's largest tech companies, significant disparities exist in healthcare access, with many service workers, gig economy employees, and essential workers lacking employer-provided insurance

CA Congressional District 17 Medicaid/Medi-Cal Facts

Total coverage: 175,000 people

This represents 23% of the district's population

An additional 32,000+ residents receive Covered California premium subsidies

Combined, over 207,000 people (28% of the district) rely on Medi-Cal or Covered CA subsidies

Estimated enrollment breakdown:

- 61,000 children (18 and under)
- 35,000 seniors and disabled adults
- 79,000 working adults and caregivers

Economic impact: Approximately \$2.1 billion in annual Medi-Cal spending in the district

Healthcare infrastructure at risk:

- Santa Clara Valley Medical Center serves as a critical safety-net facility, with Medicaid funding essential for emergency, trauma, and specialty care services
- Kaiser Permanente facilities and other hospitals throughout the district serve significant Medi-Cal populations
- Community health centers in diverse Silicon Valley neighborhoods rely on Medicaid funding to provide accessible care
- Long-term care and specialty facilities serving the region's diverse population depend on Medicaid reimbursements
