PROTECT HUD FUNDING IN CA-19: Ensuring Housing Stability for Our Communities

What is HUD? Vital Programs for CA-19 The U.S. Department of Housing and Urban Development (HUD) provides crucial support through programs like:

- Housing Choice Vouchers (Section 8): Helps low-income families afford housing.
- Continuum of Care (CoC) grants: Funds homelessness services.
- HOME & CDBG: Supports affordable housing and community development.

CA-19 Housing By the Numbers - Housing Choice Vouchers currently serve:

- 15,000+ households through Housing Authority of the County of Santa Cruz
- 10,000+ households through Housing Authority of Monterey County
- 5,000+ households through Housing Authority of San Luis Obispo County (northern portion)

Community Development & Infrastructure:

- CDBG funds support vital infrastructure in coastal and agricultural communities
- HUD investments in transit-oriented development and mixed-use housing
- Community grants fund revitalization in underserved neighborhoods
- Green infrastructure initiatives support climate resilience along the Central Coast

Affordable Housing Projects:

- Pacific Station North: 128-unit affordable housing complex in Santa Cruz
- Resetar Residential Hotel: 89 supportive housing units in Watsonville
- Tiburon Place: 68-unit low-income housing development in San Luis Obispo
- Housing waiting lists receive 5× more applications than available units

The Housing Crisis in Numbers

- 30,000+ households rely on Housing Choice Vouchers in the district
- Housing costs ↑ 76% since 2020 | Wages ↑ only 22%
- 2-bedroom rent: \$2,950/month (Santa Cruz) to \$3,300/month (Monterey)
- 28% of district renters spend over 50% of income on rent

The Impossible Gap

- Average voucher recipient earns: \$22,400/year
- Living wage needed for a family of four: \$58,750/year per adult
- → Voucher recipients would need to more than double their income

Impact on District Residents - Vulnerable populations:

- Many households earn less than 30% of Area Median Income (\$44,850 for 1 person, \$64,050 for a family of 4)
- 19% of public housing units are occupied by disabled residents
- 22% of public housing units are occupied by seniors
- A significant veteran population relies on HUD-VASH assistance

Coastal Community Challenges:

- Limited affordable housing in high-tourism areas of Monterey, Santa Cruz, and San Luis Obispo counties
- Severe shortages for service and agricultural workers
- Highly competitive rental market with rising barriers to access
- Growing displacement of working families as costs escalate

Time to Take Action!

Threats to HUD Funding - Proposed Cuts Include:

- 40% reduction in rental assistance funding
- Elimination of traditional Section 8 voucher program
- Two-year time limits for "able-bodied" recipients
- · Conversion to block grants with fewer federal protections
- \$700+ million cut from homelessness programs

If Funding is Reduced:

- 30,000+ households could lose housing vouchers in the district
- Key affordable housing projects like Pacific Station North would be jeopardized
- · Homelessness would rise—especially among seniors, veterans, and disabled individuals
- · Coastal economies could suffer as tourism and agriculture lose essential workforce housing
