PROTECT HUD FUNDING IN CA-16: Ensuring Housing Stability for Our Communities

What is HUD? Vital Programs for CA-16 The U.S. Department of Housing and Urban Development (HUD) provides crucial support through programs like:

- Housing Choice Vouchers (Section 8): Helps low-income families afford housing.
- Continuum of Care (CoC) grants: Funds homelessness services.
- HOME & CDBG: Supports affordable housing and community development.

CA-16 Housing By the Numbers - Housing Choice Vouchers currently support:

- 5,203 households via Housing Authority of San Mateo County
- 19,000 households via Santa Clara County Housing Authority (partial district coverage)
- 222 Emergency Housing Vouchers issued in San Mateo County

CDBG-DR Funding:

- \$1.6+ billion statewide for wildfire and flood recovery
- Recovery support for CZU Lightning Complex fires (2020)
- Regional relief provided by Silicon Valley Community Foundation's Disaster Fund

Affordable Housing Projects Underway:

- Luna Vista (Mountain View): 108 units, \$13.5M in city investment
- Terra Bella (Mountain View): 79 units, \$7.9M in funding
- Wilton Court (Palo Alto): 61 units, half designated for people with disabilities
- Housing waiting lists receive 5× more applicants than available units

The Housing Crisis in Numbers

- 24,000+ households rely on HUD housing vouchers in the district
- Rent ↑ 76% since 2020 | Wages ↑ only 22%
- Average 2-bedroom rent: \$3,200/month
- 28% of renters pay more than half their income on rent

The Impossible Housing Gap

- Avg. voucher household income: \$22,100/year
- Living wage (family of 4): \$58,750/year per adult
- → Voucher recipients would need to more than double their income

Impact on Residents - Who is affected in CA-16?

- 48% of voucher holders are seniors (62+)
- 62% are female-headed households
- 85% earn <30% of Area Median Income (~\$41,100 for one person)
- 18% of public housing units are occupied by disabled residents

Silicon Valley's Unique Challenges:

- Median home price exceeds \$2 million the highest in California
- Only 1 out of 805 homes is affordable for middle-income families
- Less than 10% of Black and Latino households can afford a median-priced home
- Mountain View, Palo Alto, and nearby cities offer extremely limited affordable housing

Time to Take Action!

Threats to HUD Funding - Proposed Cuts Include:

- 40% cut to rental assistance
- Elimination of Section 8 vouchers
- Two-year time limits for able-bodied recipients
- \$700M+ cut from homelessness programs
- Conversion to block grants with fewer federal protections

If Enacted, These Cuts Would:

- Endanger housing for 24,000+ households
- Jeopardize \$1.6B+ in disaster recovery
- Stall key housing projects like Luna Vista and Terra Bella
- Increase homelessness among seniors, disabled residents, and families
- · Worsen economic inequities as workers can't afford to live near jobs
