# **Protect HUD Funding in CA-06: Ensuring Housing Stability for Our Communities**

## What is HUD? Vital Programs for CA-06 The Department of Housing and Urban Development

- Housing Choice Vouchers (Section 8) help low-income families afford decent housing.
- Continuum of Care (CoC) grants fund homelessness programs and services
- **HOME and CDBG** programs fund affordable housing construction and community development.

#### **CA-06 Housing By the Numbers**

#### Housing Choice Vouchers currently serve:

- 13,084 families through Sacramento Housing Authority (payments go to landlords)
- Covers numerous communities including Rancho Cordova, Citrus Heights, North Sacramento, Fair Oaks, Gold River, Carmichael, and more
- SHRA pays approximately \$15-16 million monthly to landlords for these families

#### **CDBG-DR Funding:**

- HUD's Community Development Block Grant Disaster Recovery (CDBG-DR) program supports recovery efforts
- These funds help rebuild housing destroyed by disasters in the district
- CDBG-DR money has been used to support resilient infrastructure projects

#### **Affordable Housing:**

- Sunrise Pointe: 47-unit complex in Citrus Heights (first affordable housing in 20 years)
- 805 R Street development of 241 affordable units with commercial space
- Mutual Housing and Capital Area Development Authority (CADA) collaborative projects

#### **Impact on District Residents**

#### Vulnerable populations:

- Median income for voucher recipients: approximately \$21,412 per year
- Many households earn less than 30% of Area Median Income (\$24,750 for 1 person, \$35,350 for family of 4)
- Significant percentage of disabled residents (10.5%-18.24% across various programs)
- Senior citizens making up nearly 20% of public housing residents



## Time to Take Action!

#### Suburban housing challenges:

- Growing need for affordable housing in suburban communities like Rancho Cordova, Citrus Heights, and Fair Oaks
- Increasing rent pressures as residents seek more affordable options outside urban core
- Suburban homelessness becoming more visible with limited support infrastructure
- Need for transportation-accessible affordable housing in suburban settings

#### **Proposed HUD Cuts Include:**

- 40% reduction in rental assistance funding
- Elimination of traditional Section 8 voucher program
- Two-year time limits for "able-bodied" recipients
- Block grants to states with fewer federal protections
- \$700+ million cut from homelessness programs

#### **Impact of two-year time limits:**

- Would harm working families who need assistance due to Sacramento's housing crisis
- Average voucher recipient income (\$21,412) is less than 40% of the Area Living Wage (\$55,653 annually)
- Fair market rents increased 55% between 2020-2024, drastically outpacing wages
- Creates housing insecurity before families achieve economic stability
- Disrupts neighborhood stability and community investment in suburban areas
