## **Protect Medicaid Funding in Congressional District 04**

#### What is Medicaid/Medi-Cal?

Medicaid (Medi-Cal in California) provides healthcare for 15+ million Californians. Federal cuts would severely impact healthcare access statewide.

## California's Medi-Cal Funding

Total funding: \$184 billion (FY 2024-25)

- \$107 billion Federal funding (58%)
- \$37.6 billion State general fund (20%)
- \$39.4 billion Local government, health plan fees, provider taxes (22%) (also under threat of cuts)

### Direct Impact on Wine Country and North Bay CA-04

- Wine industry workforce vulnerability: CA-04 is home to world-renowned Napa and Sonoma wine regions where many agricultural workers and hospitality employees rely on Medi-Cal coverage
- Rural and agricultural communities at risk: CA-04 includes rural Lake and Yolo counties where healthcare access is already limited
- **Dual-eligible seniors:** Many retirees moved to wine country communities for affordability but now depend on both Medicare and Medicaid for comprehensive care
- Agricultural workforce dependence: Many farm workers in the vineyards and fields
  depend on Medi-Cal for basic healthcare, particularly given the physical demands and
  health risks of agricultural work

## CA Congressional District 4 Medicaid/Medi-Cal Facts

**Total coverage:** Approximately **183,000** people depend on Medi-Cal in CA-04

- This represents about 24% of the district's population
- An additional 35,000+ residents receive Covered California premium subsidies
- Combined, over 218,000 people (nearly 29% of the district) rely on Medi-Cal or Covered CA subsidies

**Economic impact:** \$2.3 billion in annual Medi-Cal spending in the district

### Healthcare infrastructure at risk:

- Medi-Cal supports over 15,000 jobs through healthcare spending alone
- Rural hospitals and clinics rely on Medicaid for approximately 25-30% of their funding

## **Time to Take Action!**

• Provider network: Critical access to specialists, primary care providers, and hospitals serving wine country's seasonal workforce

**Potential impact of cuts:** Up to \$2 billion in federal funding losses over nine years if cuts are applied proportionally

#### Essential healthcare services at risk:

- Primary care for agricultural and hospitality workers
- Seasonal worker healthcare access during harvest seasons
- Mental health and substance use treatment services
- Long-term care for rural seniors in wine country
- Maternal and child healthcare for farmworker families
- Emergency services in rural Lake County and agricultural areas

### **Current Budget Process**

- House passed resolution calling for \$880 billion in cuts from Energy & Commerce
- Both chambers adopted joint budget resolution on April 10, 2025
- Committee markups expected in May with final passage targeted by Memorial Day
