PROTECT HUD FUNDING IN CA-13: Ensuring Housing Stability for Our Communities

What is HUD? Vital Programs for CA-13 The U.S. Department of Housing and Urban Development (HUD) provides crucial support through programs like:

- Housing Choice Vouchers (Section 8): Helps low-income families afford housing.
- Continuum of Care (CoC) grants: Funds homelessness services.
- HOME & CDBG: Supports affordable housing and community development.

CA-13 Housing By the Numbers - Housing Choice Vouchers currently serve:

- 4,900+ households through Stanislaus County Housing Authority
- 4,800+ households through Merced County Housing Authority
- 2,200+ households through Madera County Housing Authority
- · Multiple households through other affiliated housing authorities in the district

CDBG and Disaster Recovery Funding:

- Critical CDBG funding for infrastructure and housing in rural areas
- Flood protection funding for San Joaquin Valley communities
- Drought resilience programs for agricultural areas
- HUD-funded initiatives for agricultural worker housing

Affordable Housing Projects:

- Merced Station 66-unit development near UC Merced
- King View Estates 57-unit project in Madera
- Bear Creek Terrace 80 units for agricultural workers
- South Merced Family Apartments 66-unit affordable complex

The Housing Crisis in Numbers

- 11,900+ households rely on vouchers in the district
- Housing costs up 54% since 2020 | Wages up only 16%
- Average voucher income: \$22,100/year
- Living wage (family of 4): \$45,800/adult/year
- Two working parents need: \$91,600/year total & Single parent needs: \$91,600/year
- Voucher recipients would need to increase income by 4–5x to survive without assistance
- Average 2-bedroom rent: \$1,650/month
- 34% of district renters spend over 50% of income on rent

Impact on District Residents

Many earn less than 30% of Area Median Income (\$24,050/individual, \$34,350/family of 4) 21% of public housing residents are disabled & 23% are seniors

Rural and Agricultural Community Needs

- Limited affordable housing in Merced, Stanislaus, and Madera rural areas
- Transportation challenges increase housing burden
- Farmworkers and rural families face severe housing shortages
- Lack of development threatens economic growth in agricultural regions

Threats to HUD Funding

Proposed cuts include:

- 40% reduction in rental assistance
- Elimination of Section 8 vouchers
- Two-year limits for "able-bodied" recipients

Time to Take Action!

- Block grants with fewer federal protections
- \$700M+ cut to homelessness programs

If Funding is Reduced:

- 11,900+ households could lose vouchers
- Projects like Merced Station and King View Estates would be at risk
- · Homelessness would rise—especially among seniors, farmworkers, and disabled residents
- Infrastructure investment in Central Valley communities would be severely reduced
