Protect HUD Funding in CA-05: Ensuring Housing Stability for Our Communities

What is HUD? Vital Programs for CA-05 The U.S. Department of Housing and Urban Development (HUD) provides critical support through programs like:

- Housing Choice Vouchers (Section 8) help low-income families afford decent housing.
- Continuum of Care (CoC) grants fund homelessness programs and services
- HOME and CDBG programs fund affordable housing construction and community development.

CA-05 Housing By the Numbers

Housing Choice Vouchers currently serve:

- 5,074+ households through Stanislaus Regional Housing Authority (serves Stanislaus, Amador, Calaveras, Tuolumne, Mariposa, Alpine, Inyo, Mono counties)
- 741 households through Housing Authority of the City of Madera
- Additional households through eastern Fresno County Housing Authority (13,000+ total vouchers)
- Many families through affiliated housing authorities in the district.

CDBG-DR Funding:

- \$147.5 million in CDBG-DR funds specifically available for multifamily housing projects in wildfire-affected areas
- Over \$27.5 million awarded by Sierra Nevada Conservancy for wildfire recovery and forest resilience projects in district counties
- Critical funding for rebuilding communities in the highest wildfire-risk counties in California
- Additional federal disaster recovery allocations of \$12+ billion available for recent disasters

Affordable Housing:

- King Kennedy Veteran Cottages: 23 detached units of permanent supportive housing for veterans in Modesto
- STANCO Project Homekey: Multi-family units converted to permanent supportive housing for homeless individuals
- Multiple HOME program projects throughout Madera and Central Valley communities

The Housing Crisis in Numbers:

6,800+ households rely on Housing Choice Vouchers in the district Housing costs: Up 54% since 2020 | Wages: Up only 16%

The Impossible Housing Gap:

- Modesto median home price: \$439,000-\$465,000
- Average voucher recipient earns: \$22,100/year
- Living wage needed for family of four: \$48,600/year per adult
- Gap: Voucher recipients would need to MORE THAN DOUBLE their income

2-bedroom rent: \$1,650/month (district average)

32% of district renters spend over 50% of income on rent

Time to Take Action!

Impact on District Residents

Vulnerable populations:

- 91% of Stanislaus Regional Housing Authority participants are very low-income (under 50% AMI)
- 59% are extremely low-income across the entire district (under 30% AMI)
- Significant veteran population dependent on HUD-VASH programs
- Rural communities with limited housing options and long waiting lists (up to 10 years for public housing)

Extreme wildfire risk across the district:

- Tuolumne County: 82% of homes at substantial wildfire risk (worst in California)
- Mariposa County: 67% of homes at risk (4th worst in California)
- Calaveras, Amador, El Dorado counties also rank in top 10 statewide for wildfire risk
- Insurance companies have largely abandoned the Sierra foothills due to fire risk
- Ongoing rebuilding and recovery efforts dependent on federal assistance

Gold Country and Central Valley challenges:

- Limited affordable housing in historic Gold Country communities like Jackson, Sonora, and Placerville
- Rural isolation compounds housing affordability challenges
- Tourism pressure in foothill communities reducing long-term housing stock
- Agricultural workers in Central Valley portions need affordable housing near employment

Threats to HUD Funding

Proposed cuts include:

- 40% reduction in rental assistance funding
- Elimination of traditional Section 8 voucher program
- Two-year time limits for "able-bodied" recipients
- Block grants to states with fewer federal protections
- \$700+ million cut from homelessness programs

Impact of two-year time limits:

- Would harm working families—most non-elderly, non-disabled recipients are employed
- Average voucher recipient income (\$22,100) is less than 45% of the MIT Living Wage (\$48,600 annually) for the Central Valley region
- Fair market rents increased 54% between 2020-2024, drastically outpacing the 16% wage growth in the region
- Annual housing cost estimated at \$19,800 for single adults, \$26,400 for families with children in the Gold Country/Central Valley
- Creates housing instability during crucial periods of children's development in rural school districts
- Disrupts established school attendance and educational progress in small mountain and valley communities
- Particularly devastating in wildfire-prone areas where families need long-term stability for recovery

Sample Script When Calling
