Protect Medicaid Funding in Congressional District 15

Medicaid (Medi-Cal in California) provides healthcare for 15+ million Californians. Federal cuts would severely impact healthcare access statewide.

California's Medi-Cal Funding

Total funding: \$184 billion (FY 2024-25)

\$107 billion Federal funding (58%) \$37.6 billion State general fund (20%) \$39.4 billion Local government, health plan fees, provider taxes (22%) (also under threat of cuts)

Direct Impact on San Mateo County and Southeast San Francisco CA-15

Tech corridor workforce vulnerability: CA-15 includes San Mateo County's tech corridor where many service workers, contractors, and families depend on Medi-Cal for affordable healthcare coverage

Peninsula healthcare hub at risk: San Mateo Medical Center serves as a critical safety-net hospital for the entire Peninsula, with Medicaid funding essential for emergency and trauma services

Diverse suburban and urban communities: CA-15's mix of San Mateo County suburbs and southeast San Francisco neighborhoods include working families, immigrants, and service workers who rely on Medi-Cal for family healthcare

Health Plan of San Mateo (HPSM) dependence: HPSM manages Medi-Cal services for the entire county, coordinating care across multiple hospitals, clinics, and specialty providers

CA Congressional District 15 Medicaid/Medi-Cal Facts

Total coverage: Approximately 223,000 people depend on Medi-Cal in CA-15 This represents about 30% of the district's population An additional 28,000+ residents receive Covered California premium subsidies Combined, over 251,000 people (34% of the district) rely on Medi-Cal or Covered CA subsidies

Estimated enrollment breakdown:

- 78,000 children (18 and under)
- 45,000 seniors and disabled adults
- 100,000 working adults and caregivers

Economic impact: Approximately \$2.67 billion in annual Medi-Cal spending in the district

Time to Take Action!

- San Mateo Medical Center, the county's safety-net hospital, depends heavily on Medicaid reimbursements for emergency, trauma, and specialty care services
- Peninsula hospitals like Kaiser Permanente San Mateo, Sequoia Hospital, and Mills-Peninsula Medical Center serve significant Medi-Cal populations
- Community health centers throughout San Mateo County rely on Medicaid funding to serve diverse, multilingual communities
- Health Plan of San Mateo coordinates care for all Medi-Cal members in the county

Potential impact of cuts: Up to \$2.3 billion in federal funding losses over nine years if cuts are applied proportionally across districts

Essential healthcare services at risk:

Primary care for 223,000 residents across Peninsula communities Emergency and trauma services at San Mateo Medical Center Mental health and substance use treatment services Long-term care for seniors in suburban Peninsula communities Maternal and child healthcare for working families Specialty care serving the broader Bay Area region

Current Budget Process

House passed resolution calling for \$880 billion in cuts from Energy & Commerce Both chambers adopted joint budget resolution on April 10, 2025 Committee markups expected in May with final passage targeted **by Memorial Day**
