# **Protect Medicaid Funding in Congressional District 13**

Medicaid (**Medi-Cal** in California) provides healthcare for 15+ million Californians. Federal cuts would severely impact healthcare access statewide.

# California's Medi-Cal Funding

**Total funding:** \$174.6 billion (FY 2024-25) \$107.5B Federal funding (62%) \$37.6B State general fund (22%) \$29.5B Local government, health plan fees, provider taxes (16%) (also under threat of cuts)

## **Direct Impact on Central Valley CA-13**

**Central Valley agricultural workforce vulnerability:** CA-13 includes Merced, Turlock, Ceres, Patterson, Atwater, and parts of Modesto and Fresno County, where agricultural workers, food processing employees, and seasonal workers depend heavily on Medi-Cal coverage **Diverse communities at risk:** CA-13 encompasses all of Merced County and portions of Stanislaus, Madera, Fresno, and San Joaquin counties, serving diverse communities including Latino families, working parents, and rural residents

**Critical Access hospitals threatened:** Many Central Valley hospitals operate with negative margins and depend on Medicaid reimbursements to stay open and serve families traveling long distances **Rural and suburban communities:** From farm towns like Atwater and Chowchilla to suburban areas of Turlock and Modesto, many working families rely on Medi-Cal for comprehensive healthcare

# CA Congressional District 13 Medicaid/Medi-Cal Facts

## Total coverage: 417,800 people

This represents **54% of the district's population- among the highest in California** An additional **30,000+ residents receive Covered California** premium subsidies Combined, over 477,800 people (**57% of the district**) rely on Medi-Cal or Covered CA subsidies

## Estimated enrollment breakdown:

- 146,300 children (18 and under)
- 584,000 seniors and disabled adults
- 187,500 working adults and caregivers

Economic impact: Approximately \$5 billion in annual Medi-Cal spending in the district

## Healthcare infrastructure at risk:

- Medi-Cal supports thousands of jobs at hospitals like Mercy Medical Center Merced and Emanuel Medical Center in Turlock
- Community health centers throughout the Central Valley rely heavily on Medicaid funding to serve diverse, multilingual agricultural communities
- Rural hospitals in Merced, Atwater, and other farming communities depend on Medicaid reimbursements for emergency and specialty care

**Potential impact of cuts:** Up to \$4.3 billion in federal funding losses over nine years if cuts are applied proportionally across districts
